Attended Funeral (funeral director's charges only)

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

Taking care of all necessary legal and administrative arrangements.	£1292.00
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care.	£250.00
Care of the deceased person before the funeral in appropriate facilities. The deceased person will only be kept at the funeral director's branch premises.	£1.00
Providing a suitable coffin, this will be made from veneered oak or 'lifeart' coffin.	£455.00
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer).	£1.00
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle.	£425.00

Unattended Funeral

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

Burial (funeral director's charges only).	£1250.00
Cremation (funeral director's charges plus the cremation fee) ²	£1250.00

FEES YOU MUST PAY

For an Attended or Unattended burial funeral, the **burial fee**¹.

- In this local area, the typical cost of the burial fee for a local resident is: For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.

For an Attended cremation funeral, the **cremation fee**².

- In this local area, the typical cost of a cremation for local residents is:

¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave or for reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors fee as well. This is the charge for a doctor to sign the Medical Certificates for Cremation.

Our Terms of Business

By appointing Averil Phillips and Family as your funeral director, you agree to our Terms of Business which include the following:

- The client has rights to cancel the contract within fourteen calendar days starting on the day that the contract (Estimate of Funeral Charges) is signed. Cancellation should be communicated in writing by post or by email.
- Payment of a deposit before the funeral takes place of no less than the total disbursement cost or in the event of a simple or unattended (direct) funeral the full cost shall be payable before the funeral can take place.
- Once an invoice has been issued the client is liable to pay within 14 days of receipt. If payment is not received Averil Phillips and Family reserves the right to charge 2% interest per month and is entitled to charge interest at the rate of 2% per month or part thereof on any sums due and which remain unpaid at the expiry of 14 days from the date on which they became due and continuing both after and before any judgement.
- In addition to the above, Averil Phillips and Family may pass on to the client the cost of and third-party charges or fees (such as but not limited to Court, Sheriff, advocates' and solicitor's fees) that it has incurred in the collection of a debt.
- Due to the nature of the work undertaken, the client may require Averil Phillips and Family to commence work during the cancellation period. By signing the Estimate of Funeral Charges, the client understands and agrees that, where the client cancels in accordance with their rights, reasonable payment will be due for any work carried out during the cancellation period.
- By consenting to our Terms of Business you are giving us permission to process your personal data specifically for the purposes identified. Consent is required for Averil Phillips and Family to process your personal data, but it must be explicitly given. Where we are asking you for sensitive personal data we will always tell you why and how the information will be used. You may withdraw consent at any time by contacting us to update your preferences. Please be aware that if this is during the time that we are arranging the funeral it may adversely affect our ability to carry out contractual obligations.
